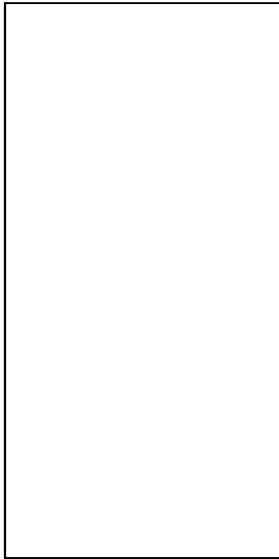

Welcome to the VCNC Walking Field Trial Saturday & Sunday, April 30 & May 1, 2011

The Vizsla Club of Northern California is pleased to present a Walking Field Trial at Hastings Island Hunting Preserve. The club management wishes us a fun and successful event predicated in part upon the adherence to the club policies listed below.

- EVERYONE** attending this event **MUST** sign in at the front desk upon arrival; and sign out just prior to departure. **NO EXCEPTIONS!**
- Drive carefully! The speed limit on the island is strictly enforced.
- Attendees may camp overnight and park in the clubhouse parking lot. Tents may be set up on the grassy areas adjacent to the parking lot. Do not drain any hose from an RV or trailer into any ditch.
- The clubhouse is open 24 hours per day and does have shower facilities.
- The refrigerators in the kitchen may be used under the supervision of Hastings Island Hunting Preserve staff and only for temporary food storage. The kitchen may not be used for cooking or food preparation.
- Dogs are not allowed in the clubhouse, on the porch, in the picnic area directly in front of the clubhouse or on the mowed lawn adjacent to the picnic area and trap range. Dogs must be leashed at all times unless they are in the fields. Please clean up after your dogs and do not tie them to trees or fences: Bring stakeouts, crates or pens.
- Smoking is **NOT** allowed in the fields.
- Our time in the field is strictly limited to the hours of 8am to 4pm! Everyone must be out of the fields and signed out by 4pm each day. No exceptions! Please assist in keeping the events on schedule by being prepared to run and at the starting area before your brace is announced.
- The above noted 8am to 4pm rules dictate that we limit our entries to the number of dogs that can be run within those hours. Mail your entry early to avoid disappointment.
- WEAR BLAZE ORANGE!** Anyone entering the course at **any level** test **MUST** wear **BLAZE ORANGE** at Hastings!!!
- Water is available from a hose by the entrance to the parking lot and water tubs will be placed in the fields for dogs.
- Food Both Days: Juice and rolls will be provided. Lunch and dinner will be for anyone who has prepaid. Lunch or dinner may be available for those who have not prepaid if there is extra.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
